### **II. Objectives and Activities**

The main objective of the trust is to bring education to the rural Indian students. The mission is to bring equal learning opportunities to the students Rural India compared to students from any corner of the world.

The RISE Trust has, hence, established and is running a school at RISE Campus, Thimmanguthu Village, Pollachi. The School is recognised by the Tamil Nadu State Education Department (License Number 630/A5/2016) and follows the rules as supervised by the District Elementary Education Department, Coimbatore.

It has been the Trust's vision that apart from bringing in a curriculum based education to the rural students, it also needs to bring in the same opportunities in education and learning to these students as is open to their counterparts in cities and elsewhere. All the activities of the trust are in accordance to that vision.

#### **School Report:**

A total of 275 students were imparted education during the year. There was a net increase of 49 (21.68% increase YOY) children availing of education from the school.

The School had one 16-seater and two 41-seater bus to provide ride to and from the school for the needy students. A total of 5 trips each way, were made between all the buses every day, ferrying 233 (84.72% of total children in school) children.

About 42 (15.27%) students were covered under the RTE, their fees to be reimbursed by the state government. Apart from these students, about 39 (14.2%) students were provided fee waivers by the trust.

A Smart Classroom was set up for the children, donated by M/s Reddington's CSR initiative.

Fee Determination Committee of the TN Govt. established the school fees to be collected for the next three years.

DTCP approval was received to cover the existing buildings as well as build 8 new classrooms and one toilet block. The building was completed in June 2018.

Matriculation License was received in March 2018 to start till Class VIII from June 2018 academic year.

A new Audio Visual Room was established by constructing a RCC roof to put it to use for all arts competitions, rehearsals and practice.

School Ground was widened and new courts laid.

## **Activities through External Organisations:**

RISE School has continued its partnership with **FIRKI** in the academic year 2017-18. Ms. Jasmine Sachdev and Ms. Anagha Nair from Teach for India visited RISE School and gave training to 5 coaches (Master Trainers) and also all other teachers. Eight online courses were selected for teachers to take from FIRKI for the academic year 2017-18. Teachers get trained in skills like lesson planning, classroom management, assessments, etc. Teachers have modified the question papers for this year's second term exams to test skills, understanding, knowledge and application levels of the children after taking a course on Summative Assessments from FIRKI's Teachers training portal.



RISE School has continued its partnership with **AID India's ELF project** in the academic year 2017-18. The Programme focuses on improving the English skills of the students from LKG to 2nd standard with digital teaching aids like ELF application in Android Tablets and also by using SMART Class. ELF personnel visit RISE School twice every month and give training to the teachers, children and also assess the improvement of the Programme regularly. Mr. Vivekananthan and Mr. Vinod from AID India help us in improving the English skills of students by giving training and support to our teachers. The goal of this program is to get children to read English fluently. Starting with letters, and progressing in step-by-step graded levels, the child moves to reading simple sentences and stories using tablets and workbooks.

**Pratham** held a training programme for the nursery school teachers in Karamadai, Metupalayam. Four teachers from RISE School participated in the training programme. We believe reading skills is the most important skill to be developed for a student to pursue bigger things in the school.



The Program for language efficacy run by Qrius Learning Initiatives through their Long Story methodology was temporarily discontinued for this academic year due to resistance from the parents and a longer time required to achieve a comparable result.

## **Events in School:**

Teachers day & Independence day were celebrated with usual fun and gaiety. Mr. R Krishnan and Mrs. Geetha Krishnan were the guests of honour during the Children's Day Celebrations. Children planned and organized various events during the teacher's day celebrations for the teachers, including Musical Chair, tug-of-war and Kabbadi.

RISE School conducted Annual Sports day for the Academic Year 2017-18 in a grand manner. Founders of RISE School, R. Krishnan and Geetha Krishnan inaugurated the event by lighting the torch. The event included both athletic events and fun games for the students from grade LKG to 7th Standard.

The Annual Day function was combined with the last Parent-Teacher Meeting, with children performing various art forms. The parents were informed of the decision to change the syllabus from Elementary to Matriculation and increase the school standards upto Class VIII.

Ms. Shanu Pant and Mr. Deepak Tulsian visited the school campus for a week and tried out online interactive lectures to students of classes 6th and 7th from the online platform Vedantu.

Arts and Craft Club, RISE School organised exhibition of the arts and crafts works of the children from 1st Standard to 7th Standard. This gave the opportunity for the children to display their creativity to the rest of the school.

In order to give an exposure to democratic process, elections are held each year to elect School Pupil Leader (SPL), Assistant School Pupil Leader (ASPL) and class representatives. Secret ballots were used to vote and all students, teachers and support staff participate in the election process.

Dr. Veena Nigam, in memory of her husband, Dr. M C Nigam donated eight tablets to the School.



## **New Initiatives:**

***Learning Circle Meetings, 'Ask Why' & Project Based Assignments*** started the previous year was continued.

A new initiative, on an experimental basis, was started to reduce the school bag being carried by the children. In this, the students kept all their books in the school and took only those books needed by them for their work overnight at home. This has considerably reduced the bag weight carried by the children.

English Club started a new initiative for the students of classes 4th to 7th. **Spell Bee** is started with the objective of making students get well versed even in difficult words. The practice was started in the 2nd term and the target was to complete A-M words. And the goal was achieved by the end of the term. We have identified students who came out with flying colours.

**Smiley Board** is a part of English club activities. We had activities like finding meanings for difficult words, finding antonyms, writing stories, writing poems, own riddles and some newspaper activities. Students were identified individually and prizes were given to the active participants. At the end of the activity, interestingly, we found students who have interest in writing poems and we have started giving more activities and projects related to them.

Financial literacy is something that we don't give importance in the school education. Maths club has taken an initiative called Children's Saving Bank to create financial literacy and savings habit among children. The teacher keeps the account of children who are the part of the scheme and also gives a passbook to each child.

A new Scholarship program was instituted by Prof. Sankar, in memory of his father Mr. Rama Iyer, to provide one-year School fees for meritorious students.

## **Awards & Recognitions:**



22 students participated in Yoga competition held at Kovai Vidhyalaya at Annur. Five students got prizes.

18 students from RISE School participated in the Karate Cup 2017 competition held in Hindustan Arts and Science College, Coimbatore. 14 students out of 18 won the medals.

40 students from RISE School participated in the Kalai Thiruvizha, Inter School Arts Festival conducted in Keshav Vidya Mandir in Pollachi. They took part in different competitions like drawing, handwriting, fancy dress, folk dance, group dance, storytelling, patriotic song etc.

This year 60 students from RISE School participated in 8th National Level Drawing Competition organised by The Art Foundation. Students from classes LKG to 7th Standard participated. The drawing competition had separate theme for each level of students.

In the inter-school and open athletics competitions, 3 students participated in the Athletic Meet at Annai School, Anamalai, 21 in Athletic meet held at Nanjiah Lingammal Polytechnic College, Coimbatore, 27 in Run for Farmers Marathon conducted by NGM College, Pollachi, 15 in Coimbatore Kidathon 2017 conducted at R K Sreerangammal Higher Secondary School, Coimbatore.

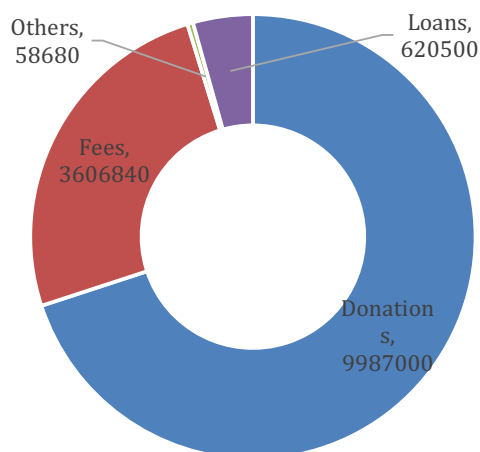

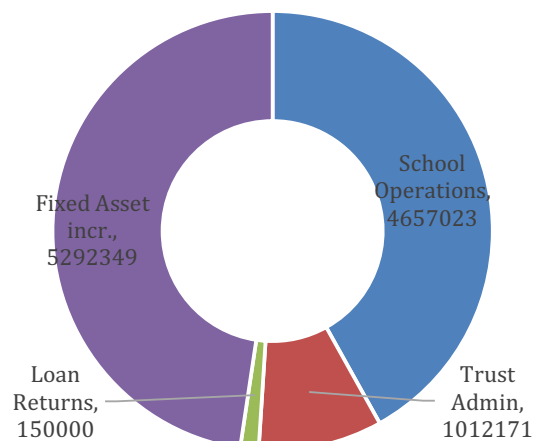

Expenses in FY1718, in Rs.

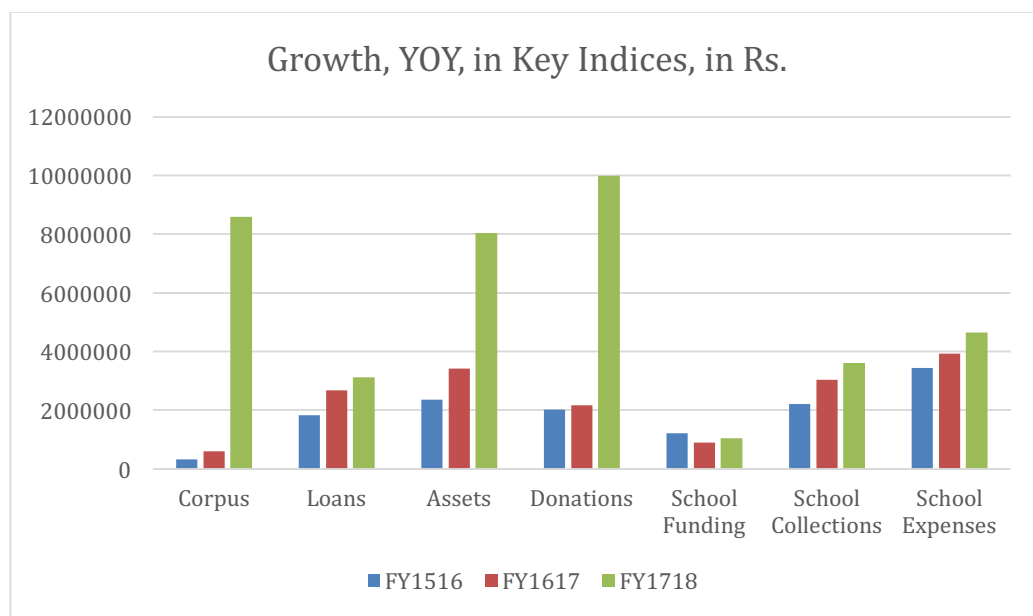


Segment wise break up of School Operations
